

# Big Brothers Big Sisters Month 2024 Giveaway

## OFFICIAL RULES

NO PURCHASE OR DONATION NECESSARY TO ENTER OR WIN. ANY DONATION WILL NOT INCREASE YOUR CHANCES OF WINNING.

**ELIGIBILITY:** Open to legal residents of fifty (50) United States and District of Columbia, 21 or older. Employees of Big Brothers Big Sisters of America (“Sponsor”), its parents, subsidiaries, affiliates, and advertising and promotion agencies or any other company involved in the execution or administration of this giveaway, and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside, and those living in their same households, whether or not related) of such individuals are not eligible to enter or win.
